





HIGHLIGHTS:


- Over 2/3 of local governments in the region purchase renewable energy
- Over 1/2 of the jurisdictions have adopted energy efficiency measures
- Nearly 90% of the communities in the region have embarked on transit oriented development and over 80% have "walkable community" initiatives
- About 70% of communities have green space protection and green infrastructure programs
- All communities in the region have recycling programs.
















Meeting the 2020 Goal – Initial Assessment

COG Advocacy Positions

- Federal Energy Legislation:
 - Promoted strengthening CAFÉ standards
 - Supported "green collar" job programs
 - Supported Energy efficiency block grants to local governments
- o Federal Climate Legislation:
 - Promoted the role of local governments/regional entities
- Endorsed Cool Capital Challenge
- Sent letter of concern re proposed coalfired power plant in Wise, Virginia







Energy – Recommendations (DRAFT)



Energy Efficiency/Demand Reduction

- Implement Regional Green Bldg Policy
- Energy perf goals for public buildings
- Adopt incentives for private bldg energy conservation
- Expand use of energy performance contracting
- Set regional energy conservation goals
- Set regional recycling goals
- Evaluate methane recapture and biosolids use as fuel at area wastewater plants

Clean Energy

- Support 20% Renewable Portfolio Standard
- Expand RGGI to DC and Virginia
- Establish region as leader in production and use of renewable energy

Local Governments Leading By Example – Energy (DRAFT)

Energy Efficiency/Demand Reduction

- Identify best practices to support reducing overall local government energy use by 15% by 2012.
- Examine feasibility of setting regional percentage goal for incorporating Energy Star® in new public buildings.
- Evaluate implementing energy efficient street lighting across the region.
- Promote energy performance contracting/facilitate implementation with regional cooperative purchase.

Clean Energy

- Evaluate setting regional green power utilization goals for local governments/explore regional cooperative purchase. – Consider 20% by 2015
- Develop a long-term goal for carbon neutrality for all government buildings.

Transportation – Recommendations (DRAFT)

Reduce VMT/Alternative modes

- Collaborate with TPB* to develop regional VMT reduction goals for 2012 and 2020.
- Collaborate with TPB to evaluate how a regional process modeled after the current regional conformity process for air quality planning might be adapted to address greenhouse gas emissions.
- Identify the percentage of auto trips under 3, 2, 1, ½ mile and develop strategy to shift half of these trips to bike or pedestrian modes.
- Evaluate greenhouse gas reduction benefits of specific increments of transit system expansion.
- Examine/implement new parking policies to reduce VMT-promote equalization of transit and parking benefits.

Vehicle Fuel Efficiency/Lower Fuel Carbon Content

- Advocate for implementation of California Low Emission Vehicle Standard (CAL LEV).
- Establish regional green fleet policy with measurable goals and timetables.

Recommendations – Land Use (DRAFT)

- Evaluate the benefits from achieving a range of possible goals (up to 95%) for directing new residential and commercial growth to regional activity centers.
- Consider establishment of transit oriented development as the region's preferred growth policy
- Establish goal and develop program and plan to achieve a "no net loss" in the region's tree canopy.
- Identify best practices enabling local governments to include greenhouse gas reduction and energy efficiency/conservation as elements in their local comprehensive planning.
- Devise a consistent, standardized methodology for evaluating the greenhouse gas emission from proposed individual development projects.

Selected Additional Recommendations (DRAFT)

- Develop regional plans for meeting 2012 and 2020 goals and regional tracking system
- Promote green business, green jobs, cooperative green purchasing
- Promote local food production options, local vendors and suppliers.

- Implement regional climate and energy outreach program
- Partner with university to develop 2050 regional climate impacts report/adaptation strategy
- Establish COG Board
 Climate and Energy
 Policy Committee
